2021 Health Equity Evaluation: Laying the Foundation



In 2020 the Spectrum Health board of directors approved a \$1 million award from the health equity endowment and directed the team to use 2021 to lay the foundation for health equity into the future. Four key findings from the evaluation are shared in this executive summary..

Important Organizational Structures to Support Health Equity were Created in 2021

Governance

Several important leadership committees were established to provide oversight and direction to the health equity work at SHL including community advisory groups. New and diverse perspectives were added to the Population Health Board Committee to increase community representation.

Strategic Direction

Frameworks to guide health equity were identified and developed in 2021 forming critical component parts for guiding this work in the future. These frameworks are important to future alignment and planning of health equity work now and into the future.

Leadership

The appointment of Dr. Lynn Todman as Vice President, Health Equity, at the Spectrum Health System level demonstrated commitment, and squarely positions health equity inside conversations at the highest levels of leadership. Two key hires at the divisional level helped fill out a leadership team for health equity.

Funding

The first award of \$1 million was made from the health equity endowment fund in late 2020 to sustain the Center for Better Health. An additional award of \$2.5 million was approved in late 2021 to support the expansion of the Center for Better Health and health equity in 2022.



The Center for Better Health was Launched and Expanded in 2021

The Center for Better Health, located in downtown Benton Harbor continued operating in 2021 supported by a \$1 million award from the health equity fund in late 2020 approved by the SHL board. The reach continued to grow due mainly to word-of-mouth messaging from clients who appreciated both the service offerings and the welcoming and safe environment created by staff. As expansion planning continues the Center continues to be a cornerstone of health equity work at SHL.
